SWIFT WATER RESCUE

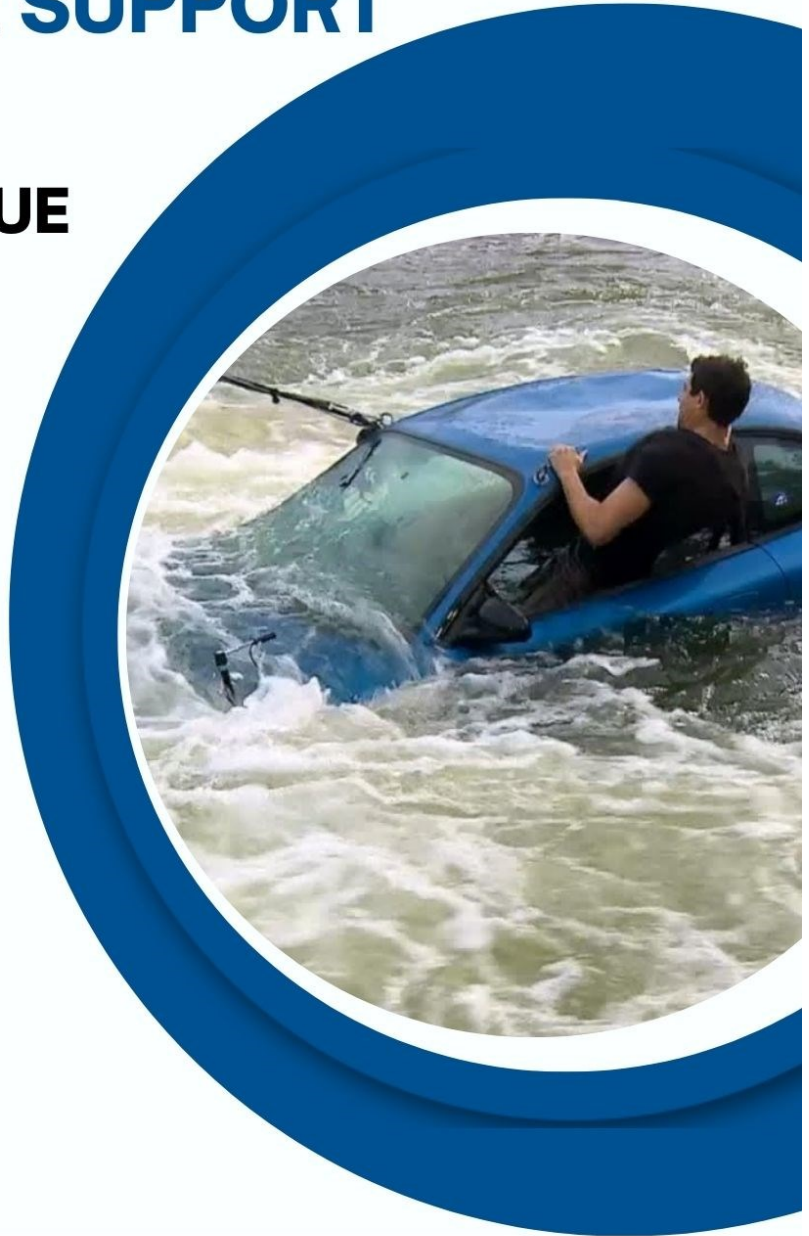
The **Ash-Rand** swift-water rescue team was a welcome sight to the three men stranded on a cartop in raging floodwaters.
